APPLICATION OF TRAFFIC RESPONSE...provides classroom lecture and on-campus lab where students will learn and apply skills addressed in the following Department of Justice 720 Academy Phase III topics: Traffic Law Enforcement-Core and Radar, Traffic Crash Investigations & Incident Management, Operating a Motor Vehicle While Intoxicated (OMVWI), and Standardized Field Sobriety Tests (SFST).
